# PART OF CONSTITUTION AND BYE-LAWS OF CHHATTISGARH STATE OPHTHALMOLOGICAL SOCIETY WORKING AREA-CHHATTISGARH

#### **Article 4 : Membership :**

To become a member of the society, person should be (i) Above 18 years (ii) Should be Indian, (iii) Willingness to follow the rules & regulations of the society (iv) should be of good character and should be Non- alcoholic. The members of the society shall consist of —

- (I) <u>LIFE MEMBERSHIP</u> Qualified Ophthalmologists with allopathic qualification recognized under schedule I or III of the Indian Medical Council Act 1956, who is practicing or working and living in Chhattisgarh shall be eligible for Life Membership.
- (ii) A. <u>INTERNATIONAL & NATIONAL MEMBER</u> Qualified Ophthalmologists working or practicing out of Chhattisgarh or India may become life member. They will not be allowed to contest for any post in the society.
- (ii) B. HONORARY MEMBER Any person who has rendered outstanding service to Ophthalmology in general and Indian Ophthalmology in particular, may be elected as a Honorary member, provided his name is unanimously recommended by the /executive committee and passed by 2/3rd majority at meeting of the general body . He shall be entitled to participate in all the activities of the society but shall not be entitled to vote at the meeting and contest for the office in the society .
- (iii) The society will keep a membership register accordingly.

### Article 6: Privileges of Membership:

- (I) All life members shall be entitled to participate in all the activities of the Society including the right to vote and shall also be entitled to receive publications of the society as provided in the bye laws.
- (ii) The application for membership duly proposed and seconded by members of the association shall be recommended by the executive committee and ratified by the general body for admission to the society.
- (iii) Any new member whose application is under consideration is entitled to attend and take part in the deliberation of the conference of society if it is held prior to his membership, being approved by the General Body but will not have the right to vote till his membership is duly ratified by the society.
- (iv) National / International life members, and Honorary members shall be entitled to participate in all the activities of the society but shall not be entitled to vote at a meeting of the society or hold a position of office.
